All Print Supplies, 'Wrapfest 2024 Wing Mirror Wrapping Competition' - Terms and Conditions Of Entry

- 1) The competition promoter is All Print Supplies Ltd (Registered in England No. 3744718) whose registered office is at All Print Supplies Ltd. 7b Fairlie Road, Slough, Berkshire SL1 4PY.
- 2) The competition is open to anyone attending Wrapfest 2024 at Silverstone Circuit, UK (to be held on 3rd-4th Oct 2024), who is aged 18 years or over, except employees of All Print Supplies Ltd and their close relatives and anyone otherwise connected with the organisation or judging of the competition.
- 3) There is no entry fee and no purchase necessary to enter this competition.
- 4) By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
- 5) Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.
- 6) We will be running one competition on Thursday 3rd October 2024 and one competition on Friday 4th October 2024.
There will be 3 x prizes per day, consisting of a 1st, 2nd and 3rd place. After this date no further entries to the competition are permitted.

To enter our wing mirror wrapping competition, simply visit All Print Supplies on Stand 19 (upstairs) at Wrapfest 2024 and talk to one of our representatives on the stand who will help you to complete an entry form, where we will take some basic personal details from you.
Each entrant will have up to 15 minutes to use our pre-printed demo samples to wrap 1 of the wing mirrors on our podiums situated on our main stand (Stand 19 upstairs).
We may have up to 3 simultaneous wraps going off at once, all will need to start and finish at the same time and will be timed by our designated judges. Heat guns and squeegees will be provided by us and the wing mirrors will have been cleaned prior to application. We will have a pre-wrapped mirror to show as an example of how it should look. Entries close at 2.30pm on both days.

- 9) How winners will be chosen: At the end of each competition our 3 designated judges will judge each wrap to pre-determined competition criteria and score marks out of 100 over various categories i.e appearance, distortion, accuracy etc.
Entrants will be scored and then based on these unbiased and impartial scores we will be entered into the competition, offering a 1st, 2nd and 3rd prize on the Thursday and the same on the Friday.
- 10) All winners will be notified by text message at 3pm each day. Winners will be required to come back to the APS stand before leaving to collect their winners voucher (prizes for 1st / 2nd will be sent within 1 week of the show ending, entrants must ensure they leave up-to-date contact information and delivery address). The APS material voucher has to be used by 30th November 2024, quoting the unique discount code displayed on the voucher when they place the order via phone/email.
If a winner cannot be contacted or does not claim the prize within 1 day of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
